

Shipping 1Fe-LSD in the EU

Theoretically, under the [Mutual Recognition of Goods Act](#), you could send 1Fe-LSD to any EU country. However, in this case, unlike with psilocybin truffles for example, countries are allowed to deviate from this law.

To mitigate risks, Primal Focus takes these measures:

1. We make our customers aware that we do not want to process transactions for orders to EU countries where 1Fe-LSD is prohibited.
2. We check the laws per country annually for changes.
